

This is a conversation taken with the mother 13.06-2021, Two weeks before the child service meeting. Everything before the clock is just nonsense.

16.00

Marius "no, it is not" I am telling no to that the kindergarten is a good choice

Mother "no, what?"

Marius "it is a downgrade"

Mother "a downgrade from what?"

Marius "of what she have"

Mother "what does she have now?"

Marius "a school"

Mother "but Marius, like said now that time is done, she have learned much from that, and have had it really, but noow she is coming home, right?"

Marius "now she is being downgraded" the main reason for us to agree on the years was first of all Nova. What was the point to go to school and then to kindergarten and then back to school. And off course that Leon smashed every results there was.

Mother "I dont see it that way"

Marius "but unfortunate, that is what it is."

Mother "I mean that it is still much to learn ang be given from good kindergartens here."

Marius "downgrade from your banc job and go down to a sales floor"

Mother "what did you say?"

Marius "downgrade from your banc job to a sales floor and then start back up again with your banc job in a year"

Mother "I am on the sales floor Marius, what do you think I am doing in a banc?"

Marius "down from your banc floor, since you have become a banc woman, and then downgrade to an ordinary sales floor, sell what the hell you want, sell what the hell you want, and then when it goes a year the you go back to where you are today."

Mother "why should I do that Marius?"

Marius "that is what you are doing to Nova"

Mother "no that is not what I am doing to Nova"

Marius "yes, it is even worse"

Mother "you can mean that Marius"

Marius "since you started in this job for not so long ago. And you did all your tests from January to February, you have not been authorized from when? Four months?"

Mother "I am not authorized"

Marius "Nova have actually been in school 8-9 months and you are then putting her back into a kindergarten when she is in a perfect environment."

Mother "Marius, about what the child service are telling are they not agreeing with that."

Marius "you have never got anything on Nova"

Mother "but it is a little special to talk to you about it since you haven't got anything from them on this."

Marius "you have never heard anything about Nova"

Mother "yes, they have spoken about Nova as well, but this you will hear from them. So we wont talk about this between you and me."

Marius "what have they said about Nova?"

Mother "why should I say that, I told you to take contact with them and every time I tell you something then you tell me I am lying" she was lying.

Marius "there is no one that have been talking to me about Nova"

Mother "yes, but it is many things they did not talk to you about, and that is obvious"

Marius "ok, but what?"

Mother "I have now told you that you should talk to them"

Marius "you told me that you have spoken to them"

Mother "yes, I have done that."

Marius "yes, about what? Have the come with a worry about Nova?" I just want her to take the lie to the next step. The reason for this is that I was in a meeting with Nova school a couple of days before. And they were really happy about everything with Nova and really loved her. They did not tell me that child service had contacted them, I was the one that said I had a case first. Reason for this is because they wanted to hear if Nova was starting after summer again. Then I told them about the situation. The teachers told me that they said in the phone, Nova was always clean, always happy, had good learning skills in writing, reading and in learning Spanish. So I knew what the school had said. That is why I pushed her more.

Mother "why should I say that to you when you don't believe me anyway"

Marius "have they stated a concern about Nova?"

Mother "yes, they have stated a concern about Nova"

Marius "who have stated that?"

Mother "the child service have stated a concern about Nova"

Marius "but then it should have been the school that have sent in concerns about Nova"

Mother "they did not send in any concerns no, but after observation and conversations with the school have they achieved their own assessment on how they mean Nova has it." And this

is also bullshit. The child service was never at Nova's school because the teachers told them that Nova had a really nice time in school.

Marius "so what you are telling me is that the school never sent in a message, but?"

Mother "Nova's school have not sent in anything, and what they say is that this has nothing to do with you, but you are not talking the language, so it is a problem there and that they have been talking very little with you, what they have reached the conclusion on is the behavior to Nova" .... It is interesting to hear how easy her lies comes out. It just flies out.

Marius "mhm" now I didn't need anymore lies from her about the school.

19.43

Marius "yes."

Mother "yes, but this will also you get a feedback on, you will get a feedback on everything and you know that I have been positive to let this happen one more year if this was good"

Marius "you have never been positive to this"

Mother "yes, I have. This I have told you that you could do."

Marius "you have never been positive to that because you finding up fairy tales all the time now about what the problem with the kids are. It is really strange that the school to Leon and Gabriel have tried to provoke reaction on Leon that week it actually is calima, and the best thing about everything is that they cant do it since I have started to iron everything again. I steam all the clothes. They have no way of provoke anything because I am doing my job, he will be a little exposed for what they are doing but it is going to take much now before Leon is going backwards. Where he was for four- five months. Things over here starts to come to order again. The school to Leon and Gabriel have sent in that he have asthma and don't have a good time with me, but there is nothing to do with Leon, that we have understood, it is only Gabriel that is the concern" the reason I say this is because there is nothing here about Leon's emotions about school, about me, about home situation, about the things he reacts to, there is nothing. They took a conclusion without speaking to him. They went on Gabriel that will never be forgiven from my side. To make a case about a seven year old emotions, and first of all never ask me about his "emotions" so that it can be fixed. Using his emotions to put together a case against me while I am trying to protect my kids against their lying "doctor", raise concern about a paper episode that they never have spoken to Leon about. When the Calima came Leon's teacher suddenly found out that she was going to play a new game in class. And since he reacted to the paper at this school, they tried their hardest. The game went like this, there is a peace of paper on both sides of the class room, and there was a competition to run back and forward and pick the paper up. after this they called me and told me that Leon was sick. They told Leon that it had arrived a new decease to the island and many persons in the school got it and he did it as well. This was of course a lie. I thought everything was strange, first of all since he didn't look bad at all when he came into the car. So I asked him, are you sick? and he told me, no. Then I asked him, are you feeling anything at all? Yes, a little sore throat, but I don't know why I was sent home. So he wasn't sick, but still got sent home. And then he told me about this game. I know he doesn't have asthma, maybe some symptoms off coughing but no asthma because I can remove it. so that week it was

actually a really bad calima. I sent im the same day with skateboard with a friend in a skatepark for four hours after school. Then I had a Spanish teacher at my home on Tuesday. Were we sat outside. Then on Wednesday back in skatepark. And the same on Thursday. Nothing happened to Leon, no coughes at all, and when they are skating they do not have a mask on. So he practically should have been dead on Thursday. I sent a mail to four different teacher to ask Leon what he did the last week after school, but not all at once. One at the time so he will not be suspicious about why they are asking. Haha, I got no replays. They have been telling me for months that he have child asthma and I asked Leon everyday if a teacher has talked to him. Nothing. So now the school started to get even more aggressive against Leon at school. And of course against me with the way they spoke to both of us. They were as clear as day busted in bullshit. My major problem with this is that I have three kids that I am trying to save from this madness. I have Leon that went through hell for four years in Norway, I have a daughter that almost died because that the mother "disagrees" on purpose to fuck with me. And a mother that almost died as well, wrongly diagnosed, and still up to this day gets bullshit. I left Norway to seek help for my kids. And they got pissed on even more since they thought it was a good idea to make contact with child service to ruin my life more, which again would have destroyed my kids life forever. I try to protect the feeling my kids will have when they gets older. I don't want anyone to tell them that they have any form for psychological bullshit because of their strong allergic reactions to things. this is my main thing about this case, this is why I left, just to prove that my kids can be calm, can learn, can sit still, have no aggression like adhd, which I now have done. The last year have saved my kids for the rest of their life.

Mother "No, Marius."

Marius "why have you not spoken to Gabriel then?" I miss spoke, it should have been Leon

Mother "I feel this is a little eeeh, I feel that the only one we can get any constructive out of this now is that you wait until I arrive, and that we goes to the conversations that we have talked about with the people that have made this report and their concerns so that you can get that."

Marius "it is the school that has done that."

Mother "no, it is not the school, it is the child service that has done that"

Marius "noo, it is the school that did that. The children would have never been in this situation if the school wasn't there."

Mother "no, the child service have done their own decisions after they have talked to the school and talked to you, ok. It is a complete assessment here, there is like they have done their own conclusions and based it on that. So what I want is, I know that you don't believe when I say it. but when we now go away from the decision to expand this one more year, is it a reason for me to do it, it is not only to be evil.. ok?"

22.29

Marius "but, what do you think is going to happen with Leon?"

Mother "what do you mean?"

Marius "you are so sure that you are going to take him."

Mother "yes, yes, every kid is going home."

Marius "mm. but, what do you think is going to happen with Leon?"

Mother "what do you mean? Happens to Leon?"

Marius "do you think you can just brainwash him back from all your lies?"

Mother "I am busy, I am busy with finding answers that have a position in this reality."

Marius "you have told all the time here that he have asthma"

Mother "no, and again do you put words in my mouth, I have said that it looks like asthma since this is something that runs in the family, is what I have said" which family is she talking about? I had a grandmother with asthma since she smoked 30 cigarettes a day from she was 20 until she died. No one else at my side. And as I can remember no one at her side. So there is no one in the families with asthma unless you smoke yourself to it.

Marius " your lying, you and the school have said in the last year that it is asthma, and before that, and before that"

Mother "one year actually? One year?"

Marius "yes, since they begun at the school, since the begun at school. The last nine months. But before that you said for two years that it was the fifth child decease."

Mother "I told you that it could be that yes."

Marius "no, you said that your doctor had told you that it was the fifth child decease, and this you said to me for two years."

Mother "I said it looks like it could be that."

Marius "I don't give a f about what you say that it looks like. You told me that your doctor, you said to me that your doctor, you said to me that your doctor that it was the fifth child decease, and that have you told me all this time. For two years." It was longer, it was since Leon's first grade, Gabriel used to get rash reactions on and of as a child.

Mother "yes, that it could be that, that is correct I have said that."

Marius "and now when I have arrived here have you changed, and now you say asthma. But, your only problem now Kay. Is that I decided this things, and you could not come around, you thought it was easy to get asthma on him in the last calima"

Mother "at home they had rashes and now it is different, it is just stupid to compare them. When we have watched dots on the outside of the body and when this is here is about the chest " The reason I bring them up is because I have never said the kids were sick. But the mother tells everyone that I manipulate my kids sick. She says the kids have one decease after the other without any doctor confirmation. While I have doctors approval on allergic bronchitis. So who is the one that manipulates who?

Marius "dots, they have still dots, the children still have dots. I still takes pictures of Nova's body with dots on it. when she had a boxer that she wear from a store we couldn't tolerate, she still gets those dots. Last time was earlier today."

Mother "No Marius, listen to what you are saying, that she have a boxer from a store she cant tolerate"

Marius "yes."

Mother "no, no, this cant go on. It cant go on like this. You cant go around and say this things al the time. Do you not understand this."

Marius "yes"

Mother "it is just, it is very problematic, eeeh, Marius, eeeh, I want you to think about the things we have been talking about" Here is what I have tried to tell the child service in Canaria and the school, that she is in the way she says this, making me look like a mental patient. I have another human being that have seen this at the beach with me. But this Is the way she have closed my mouth for the whole relationship, and this referees back to my mothers illness again. So here you actually have prove of she doing what I have told you all. I never told her about the witness, but I have.

25.08

Marius "I will never come home kay"

Mother "you need to stop this. What?"

Marius "I will never come back home."

Mother "yes, I now, ok, I know, then the question is when I am arriving now if I will pick them up and leave"

Marius "the child serviced case is going to be done Kay. I reckons with that you understands that, you will get a problem if you are taking the kids before the case is done."

Mother "I do this in co operation with the child service, that is what I have been trying to tell you. "

Marius "yes, and that we will found out."

Mother "and when I arrives then they will tell you all, and then you get the conclusion and the conclusion is already done. They just wait for me to arrive. That is why I am asking you, there is two ways this will be dealt with now, either I come down and get the kids home and I have full support from the child service, or I will come down and then we do some conversations with the child service and you can actually get to speak out, and try to work together." This is also completely nonsense. My words in the child service meeting meant 0. It didn't matter what I say. I even brought up that kay have told me that the child service lady was saying it was dirty and filthy in my apartment, I did not get an answer as you can hear in the recording. Another false statement by the mother that no one cared about. The woman that was in my house was the woman 1 meter away form in the meeting. And you can hear it when the woman from church translator it to the child service lady.

Marius "it is no work together. It is me against you all."

Mother "ok"

Marius "it is me against you all"

Mother "ok"

Marius "I take the school in lying all the time, they tried to do everything in their power to provoke asthma on Leon, he have not asthma. It has not worked out for you. You have said in nine months now that he have asthma."

Mother "you still keep saying the thing"

Marius "the school have said the last nine months that it is asthma. Of course I am going against what you are saying"

Mother "I feel like it would be just to repeat ourself because you wont listen."

Marius "yes, and so have you done. You are saying they cant tolerate this, you are saying they get red about this, yes because they are. You know that Kay that they must check the journal on the kids regularly, so they can check what the kids are exposed at."

Mother "mm"

Marius "yes, because that day you must give your kids allergic medicine then everyone knows that everything you have done is bullshit all the time. And that day they are in the hospital because you are trying to put in the kids Anger medicine, like you have tired to make me sign on"

Mother "NO, I have never tried you to do that, stop this"

Marius "you told me to log into alltin and sign the documents when you were alone at holmlia with the kids, so you could get an evaluation on his anger issues, that is your words. You told me to log in, I have never sign that document, you signed that document"

Mother "it was the school that meant it could be this, it was they that did this, not me." This is completely bullshit, she had a really though time at holmlia with the three kids alone. So she called me and told me to sign it, and got really mad because i didn't. She was the one that triggered this forward and told me straight up that this had to be done, and referred to her own anger problems. Maybe he is like me? I am throwing things and hit things and screams like him. He got this from me. And I told her no. because I didn't believe in their stories.

Marius "if you want to put in that kid asthma medicine adhd medicine then it will not help him at all. It will not help any of your kids. And then you will get problems for that."

28.00

Mother "Marius, if that hhh"

Marius "this will only hit you back, I have done my thing, I am happy,"

Mother "ok, now you have given your answer on thing, that you will not come home."

Marius "I am happy kay."

Mother "and that is ok. And when I arrive then I will make them give you the feedback you need that it is best for the kids to be with me, and then I take the kids back to days later. And then you can do whatever you want with your life. But if you want to see your kids, and be with your kids then you have to come back to Norway."

Marius "I am done with Norway."

Mother "and I can gladly co operate with you her, but they are done with you in a foreigner country."

Marius "I am done with Norway."

Mother "ok, then that is ok. Then I know what I need to do. and as you say. You will accept the conclusion child service have, the only thing that is important for me is that it must not be an traumatic experience for the kids that it gets child service and police and everything for you to hand over the kids" again making me look like the aggressive one, haha. As you can see how she lies, how she tells me to do things with every material you have, it is quiet easy to now who the aggressive one is."

Marius "I am done when the child service is done." Here the child service fucked me over, they told me to have meetings to find out what was the best for the kids. They told me this all the time. But suddenly when I came into that meeting, like you can here in the recording there was no talking about what I meant, and the mother lied in there as well. they didn't have a conclusion until she stopped threatened me with picking up the kids before the meeting. I don't know the exact date on this. But the mother clearly somehow convinced the child service what was the best for the kids. Even though I gave them the photographs of Gabriel.

29.07

Mother "good"

Marius "mhm."

Mother "then I know that it wont be a sad thing"

Marius "I have never stated that I wouldn't give the kids away, you made the case and that will be done then you will get them." And what is really upsetting as well is that I told the child service to make appointments for the kids through their systems and did not tell me that they couldn't do it before the conclusion, even though I told them that this was the most important thing. Here they clearly just don't cared. There is like three really big things they showed me no respect on, first of all that they never told me about the test and did not got that sort out. The second, the pictures I sent of Gabriel when he was with the mother, and of course when I showed them that I had the passports and they just accepted that it was ok to leave the country illegally.

Mother "ok, then I also want you think about"

Marius "there is no reason, that you put that things in in the first place, you know I wouldn't have kept the kids."

Mother "you said that you wouldn't open the door if I came and eeeh"

Marius "no, you wont come into my house. No, you wont come into my house, why should you go into my house?"

Mother "no, then I will order a hotel room, and then I will be there for a couple of days and travel back home"



Marius "there is nothing else I have said"

Mother "then I know how it works out, then I will tell you when I arrive and etc. then you need to sort out what to have with them"

Marius "they don't need to take anything from here"

Mother "the clothes can they have with them since they are growing out of that anyway."

Marius "you have more control on this than me"

Mother "you must let the kids take with them what they want Marius"

Marius " I have always told you that it is the clothes that makes them behave themselves, so if don't mean that it is that then you can fix your own clothes"

Mother "yes, of course they will get other types of clothes since they are living in a winter country."

Marius "yes, you can fix your own clothes."

Mother "yes, that is ok."

Marius "then we can give the clothes away here to the people that actually need clothes. That don't have any money."

Mother "ok, ok,ok we can manage."

Marius "because they that are here don't have money"

Mother "ok, don't send them anything, don't let them take any toys. Don't let them take anything."

Marius "toys they can have, that is no stress. But the clothes, why take them when we can give it to the once that needs clothes here? And you are saying that it is not the clothes, then you can fix your own clothes."

Mother "I don't want to discuss clothes, that is the least important thing, but that is ok, then we have plan, I will call to speak with the kids tomorrow, bye"

Marius "mhm"

18.14 She tells me that child service have concern about the behavior of Nova. But that the school have never sent that in, but that the child service have taken their own decision about that. Something that has never happened or told to me from either parts.

19.55 She tells me that she was positive to have another year as long as everything was in order, as it was until Leon got his test back smashing all the results and gaining two semester in 4 months. she confirmed two year deal.

21.05 I tell the mother that they have nothing on Leon in this child service case, and start questioning why? everything is about Gabriels feelings. She refuses to answer of course. The reason I am saying this is because the whole case is just completely out of order of how you threat kids. To make Gabriel the victim to make a case against me is just horrendous. They have not asked Leon once have he felt in at the school. Not once how it was home. Not once about anything. Every emotion they started this case on was Gabriel. And then to start a case with his emotions that can be answered from me is just out of order. They used Gabriel since he was 7, it was an easy prey for them. And for this they will be never forgiven.

22.15 She confirms again that there was a 2-year deal and that "she" has no other choice than go away from this.

23.00 I tell the mother that she and the school have told me and Leon that Leon has asthma, She comes back with a weak answer that it "looks like it might be asthma". The reason this was a big thing for me is because she is confirming that what I have said that they have used asthma as an excuse is valid. She cant say no, I have not said that, no, the school have not said

that. So again, they are hiding the true health issue the kids have only to say that I am crazy and was telling at home that I didn't tolerate things.

23.30 I tell her that she has told me that every time when the kids where red at home, her doctor has told her that it is the fifth child decease. Red like the picture you got from me the first time. She again tells a weak answer "it might look like it" again. So my kids have had fifth Child decease 6 years now. All the way from Leon was a first grade. Then it is about to question The mother and her doctor how I can remove this fifth child decease. Because they are never this red with me.

24.00 I told her that she switched story when i got to canaria, she tries to counter with, the kids aren't red so how can it be fifth child decease that is just stupid. But her problem with that is that the kids still have the same symptoms just not red. i have managed like i did in Norway every time i picked up the kids to get rid of the red. The breathing issue has always been there, so why wasn't it asthma at home?

24.30 I tell her that the kids still gets red, i have pictures of the kids turning red here in canaria. And that Nova turns red around the bikini line with trousers that she reacts to. here she tries to say that i am crazy talking and that this is never happening. She try to let it sounds like i am crazy, she is using words like "this is why you cannot have the kids anymore. You cannot say that they are red when they are not". But, i have a witness that have seen it on the beach. The person that saw told me that he didn't want to be a part of the court case. I don't know if there are any solutions to make that anonymous? But it really doesn't matter since she is refusing the picture of Gabriel as well.

26.10 I have told her that i never come to Norway again, there has been no support for me to have a life there. And that the school actively tried to give Leon asthmatic problems under a calima. It was a monday, the calima came on sunday. WE have this backpack case, since Leon got a paper on the school and got a big reaction i managed to get rid of the backpack since the homework and all the papers where full of things we reacted to. So the teacher to Leon decided to Have a game, they have never had this game before. They must run through the class pick up a piece of paper and run back as long as they could. They sent Leon home that day and told me that i have got symptoms of a new decease that have arrived canaria the last weeks. I thought everything felt strange when Leon got in the car, so i asked him how he felt? He told me he had a little runny nose and felt it in the lungs, but not much. SO i then asked him was it you that told the school that you wanted to go home? He then told me no. The school told me that i had to go home. So since they never got the reaction they wanted since they have told me since we started that it looks like asthma, i called his best friends dad the same day, and asked if Leon and his son could do some outdoor activity this afternoon. They went to the skate park for 3 hours without mask since they were in activity, and no problems. on wednesday the same week i had a spanish teacher on visit, i asked her if all of us could sit outside. Leon sat outside for 45 min with no problems, now the calima was really bad. Thursday 4 hours skate park with friend nothing. The i sent a mail to the school. To the

principal assistant, the nurse and two teacher to aske Leon of what he did the last week outside off school by themself, not in group and give me a reply on the answer. i got nothing back. They never asked him, i never told my son that i have sent a mail. I just asked him the next weeks if someone in school has asked him certain questions, he just looked at me stranger and stranger every time.

27.15 I tell her about the time she tried to make me sign adhd paper on my son. She of course refuse to that. You have now been given the signed documents from her side on the adhd analyze she wanted on him. This was in a time where she was alone with the kids after separation and after i left the house. And again she is using the "it might have been ADHD" this is a very common political fraze they are using so that they think they can get away from pissing on my kids.

28.55 She is hinting to that i am the aggressive one in the house. It was completely opposite. If you aske Leon of what went down in that house you would have an other story like have said for 7 months, but still no one is questioning him. She tells me that i should give them away as long if child service says that this is the best way of doing it. I tell her yes, no problem. I have the child service meeting recorded where we end the meeting with the child service saying that, since there are no documents of the kids reacting we need to close the case. I told the i will get documents in two days, and they agreed. And the paper was delivered. The original is still in the hands of the child service in Maspalomas.
