

` This is a video of the conversation with the mother from 12.05. here you can see that she is going to multiple of threats against me, just so the kids gets back home before they get tested by the child service. The child service have never raised a concern about the kids welfare to their mother, something child service can confirm.

Mother "when it is important, is it ok to have an extra eye on the phone when I am telling you that I will call back."

Mother "what is happening?"

Mother "you are losing your kids and you have only yourself to blame."

Mother "you are so fucking nuts"

Mother "don't put your behaviour over on me"

Mother "it is not me under the microscope."

Mother "You and your threats"

Mother "you keep throwing shit and threatens me with shit. That is really special since it is your behaviour that has led to this. Your behaviour. That you are telling me that you won't believe in the results that will arrive black on white, that we are bought and paid for" I have like I have told everyone tried to get an appointment at the hospital in san augustin. They Have reported to the child service that the insurance didn't cover it, which is bullshit. They let me take the kids four times to their hospital and played me and the kids around. I had an appointment with the laboratory with the manager of allergic sector Elena, but when I got into the room I said no, since it was more important to test my kids. I will refuse to let her or the school to choose the place. The doctor at the school told me for 5-6 months that it looks like child asthma on Loen, something that again is bullshit. They also played me and the kids around.

Mother "it is hurting to hear"

Mother "independent on this report when everything is done will be the final say if you will have the kids one more year on Canaria, or if you should come home to Norway so that we can share the responsibility."

Mother "like you said is the kid's health most important and will be for that reason a deciding factor on what we are going to in the future with the kids."

Mother "that you are saying to the school that I should not be participating in things is never ok." I did this at the school in Canaria since I did not want the mother to know that I was trying to get tests on the kids, and prove that what's wrong with them mis not what the school or the

mother is saying. The second principal at school asked me if I wanted to share this, I told him no. everything else I don't care, but when it comes to this, don't do it. The school went against my words and the mother was noticed about this. I asked the school what the mother have told them, they said that was confidential information. So , they shared my information to the mother and hold hers. I have no idea what she said, but it is not rocket science that she said that I was crazy and manipulated the kids.

Mother "they should be able to contact me any time about everything."

Marius "I can prove that I have never threatened you with anything."

Marius "I have never been aggressive towards you"

Marius "Leon is telling me all the time that it was the opposite, that you were the one that screamed and made chaos at home."

Marius "stop the manipulation, it is not good for you."

Marius "you had your chance o Holmlia to fix the kids, you and the Norwegian system failed. Now I have proven you wrong."

Marius "what have I ever threatened you with? Tell one thing? When have I ever been aggressive against you? Tell me one time? When have I ever done anything to harm you physically and mental on purpose?" tell me one time? Do you really believe that Leon wants to go home to you? Honestly? It is your words that have broken your relationship. Not mine. I have said all the time that I am taking away things when the kids are having some sort of reactions. I have never said they have allergy. We need samples to get answers on allergy."

Mother "you are saying much shit. First it was NAV and now it is me that are not protecting the kids." NAV, Norwegian well fare system. After I started my own company I worked to hard and got kissing decease. When you are in the system they must try to rehabilitate you and come with some sort of diagnose. They tried to put anxiety on me. The "doctor" told me when I got in there 7 times in a row that I have it. The reason for seven times is because I said no. I am not scared of anything. But they tried anyway. And this was proven wrong 5 days later. The reason for that was that the next five days I was shaking uncontrolled three nights of this 5 five. And then I should have an anxiety attack, something I didn't have. I called the hospital every time had 70-80 in hearth rate while this was going on, so I actually had resting rate for the circumstances. So then this was ruled out.

Mother "you are talking like the kids were broken, it takes time to raise kids." The kids were broken. Leon was totally out of control, Gabriel was well in to behave as Leon, and Nova that was three had start to swear. So I can say, that they were out of control.

Mother "This is the second time the child service is called inn because of you, not me." They were called in on me, but this case is as easy to be proven bullshit as this one.

Mother "I have no problems to say that I was screaming to much. There is a reason why I left you and never wanted to come back into the relationship. You are not listening on people around you." This is an invalid reference, since she has screamed all the time. Something Leon also can confirm.

Mother "doing what you want and don't respect my opinion. That it is why it snapped for me. It is just to have some conversation with the people around that are trying to work with you. It is impossible. You are not listening to what people are saying and are very overtaking in conversation when we are trying to talk to you." Everyone around me in my family referred to my mother when they talked about me, and she was diagnosed with schizophrenia and something else. This was deleted like you can see in my statement, since she almost died of a decease where they couldn't give here any medicine to treat her psychological diagnoses. She went over 6 months without any medicine and was completely fine. And it is strange to let your psychologic and anxiety father to your children travel to another country while it is hell on earth for his own. So again, their words don't mean nothing. And what is funny for me is that she is telling me that she can be mad at me, and scream to the kids and me all the time because I have my own opinion.

Mother "To live 10 years with a person like this is extremely difficult. It was destroying me mentally and for other around you that had you in their life. The school will answer and stand by their statement. A new report will be written and then we will se how you will receive this feedback." She got three kids with me and it is three years apart with the kids. She got the last one seven years in to relationship. Haha, how difficult could I have been.

Mother "it is maybe for the best that we are sharing the responsibility for the kids." The only reason she wants this is like I have said many times. Then she can keep on fucking with my and the kids life. And that is not going to happen.

Mother "stop threaten me and take responsibility for your own life."

Mother "I hope you now listen to the ones that are going to assess you" Here you know that I am in a totally disagree with the Norwegian school in general. It doesn't matter if I am here, Canaria or in Norway. They have shown their true colors the last 6 years.

Marius "tell me one time I have threatened you? Tell me one time I have done you pain? Why cant you answer?" the reason why am asking about hurting her is because I asked her about that since she was always lying and so mad all the time. And she answered me with that I have hit her once when she we pregnant with Nova. And I wanted her statement in messages since she has only told me this once. But if she have told me this once, what have she told the other one. Leon has told me that she told him that I hit her multiple of times. To me only one. When I said "what the fuck are you saying, so the one time I hit you is when your sister and her boyfriend is visiting us?" after that I have never heard about it again form her to me. But, as I said, She has told Leon that I have hit her multiple of times. So this Is something i want to come up in court. I want to know every story I have "hit" her in this relationship. There is a reason for me to keep pushing for answer.

Marius "hahaha"

Mother "I just wrote 2 times where you have threatened me" I can still not find any threat I have done to her. And if I have never threatened her would I then have hit her? If you ask me you don't start with a punch in the face. It is no threat to have your own opinion.

Mother "you have hurt mentally for many years"

Marius "When?" I am trying to get some examples, but that is not happening.

Mother "the decision you made ruined this family." Here she is talking about what I did when I worked too hard and did not go to NAV. It is a simple reason for that, my doctor never told me that I have kissing disease. SO I was sure that I just needed rest. After one and a half year with pain, me and Gabriel was sick in Christmas, so I had to go to the doctor and my doctor was on holiday. I got actually the mothers doctor and he told me that we just had the cold. When it kept going for 2 weeks I went back to the doctors office, my and the mothers doctor was away, so I got the mothers doctor vicariate. Then I finally got the answer of kissing disease. So she is mad since I thought it would go over. I struggled with this on and off maybe 3 years, maybe more since I pushed myself in this time where you are supposed to just listen to your body and do nothing. It was so bad that I was driving at night with sunglasses since the light from vehicles at night was too much for my eyes.

Mother "are you reading what I am writing"

Mother "or do you not care?"

Mother "I am writing over how it is to talk with you and live with you. You changed me because you are what you are. Now you have one more side that are telling the same like me."

Mother "the school in Spain."

Mother "but you are not taking in any feedback"

Marius " everything is in the hands to the health system in Spain. I will talk with them on the road forward. And as long as we have not reached there yet, doesn't your word count for anything. Thing will be tested after meeting with them. What appointments you are trying to give me is something I don't care about. The same with appointments form the school. You wanted child service on me and that is the way we go. Something I look forward to. Now we can see how much they think about their own doctors are lying and that Norwegians don't trust Spanish doctors. It will help you and the school a lot in this case." The reason I am saying they don't trust Spanish doctors is because after the first appointment, the mother and the doctor on the school told me that the diagnose is bullshit, this is something they have never heard about. It is child asthma. And this is the reason asthma goes on and on down in Canaria.

When she first searched for child service money in Norway 2019 she actually had the kids less time than me. So the kids where probably 60-70% with me from january 2019 until may 2020. And if you go to where she begun taking money for child service amount, it started January-February 2019 when I was in the house alone with the three kids. And it was like that until may that year.
