Everyone on the page can clearly see that this is a reaction to something on my daughter which he also confirms after we discuss it. So I call him corrupt. And just to point out an obvious thing. Abuse grows aggression. I had my kids in the perfect state in school and growth. And at the mothers house it is completely opposite. So I think if we put one plus one together we all can easily see where the abuse is happening. She is breaking them down mentally and physically. But Bent say the are completely fine.

The next step is about the level Leon is on. Bent tells me that this is not true, that my son is now far behind in school. This is what the latest test showed of documentation, so I have lied to him, is what he is saying. The mother has had Leon for 6 months and he already goes downwards. That documentation of his reading test showing he is right behind is on the homepage and was done in march 2023. And the last documentation of Leon will also be put out on the page. So Leon is actually going straight down again after he got to the mother of the kids. The thing here is that I say to him that I have the documentation of the last test and he keeps on holding on his words. And use it in a report.
