

Hello, this is a reference of the meeting I had with Leons teacher Lars and principal Kristin from Den norske skole costablance 10.12/2021. This mail is to child service as well. The meeting was set from school because the mother had sent a mail to the school about my son wanting to go home, because I took his computer away. I wanted to send attachment with this mail of the evidence, but find it more secure for me to have it close to me and my lawyer. Information will only be sent if my lawyer is approving this. The only thing attached is the recording from the meeting with the school that confirms my reference from this meeting.

First we can start with why Leon started late, since you brought that up. The first of September I had my last meeting with my lawyer on gran canaria. Something I can prove. The reason this meeting was extremely important, was that I had found out that my lawyer newer sent in the case to the court system through the child service on gran canaria. SO, I needed to go in to that meeting and make him confirm on a recorder that he has told me all the way that it has been sent in. We travelled by flight 02-03 of September. We lived 2 weeks at a hotel in Alicante centrum while I was searching for apartments to live in. the third and in to fourth week we lived in rincon Benidorm, since I have found properties to watch. In this period I found my apartment and Leon started school the next day.

You have had concerned about Leons welfare with me, and need to send an report based on this. Now we going to go through your concerns.

First of all Lars clearly said that Leon wished himself home. Two days before this meeting I told Lars in a message that I have more info to assure them about the situation that has occurred the last couple of weeks. The school never wanted this information, but still took the mothers side without any further evidence of the mother manipulating Leon and his friend in a phone call while I was at the grocery store about how bad father I am, and all the things I do to Leon that are not true. I also have multiple of statements where Leon is describing the home situation and why he will have a better life with me. The school never wanted this. And made their conclusion on their own. It is very easy for me to speak about the last weeks, I took Leon's computer since he didn't do any schoolwork at home something that are extremely important since he is rated a 3-grade child today. Leon got angry, called his mum and said he wanted home and was out of control for 1 week. In this period, I have recorded most of the actions to protect myself from the mothers' statements of me manipulating my kid. And of course, the bad judgement from the school. I have somehow learned to be upfront.

Lars said that Leon was doing home school in the quarantine. He tried to justify that Leon always showed up for the video meetings with the teachers every day in quarantine. Here I called out Lars pretty quick with saying "can you find his tasks from the school?" It is really strange that a teacher is trying to lie about the kids work at school. How does this make sense? He had a book that he should have delivered the day after quarantine called "Europe trip" up to this date 10.12/2021 it is still half done in my house. He had another book about astronauts, He could choose between a comedy book or a fact book. Nothing is done. He had some math tasks he did ok one day but rest not there. So, he did one hour of math and half book that should have been delivered 9 days ago in 9 days quarantine. He did nothing at home. The teachers have full insight of the students work since they are logging in to a Norwegian school system that tracks everything. The teacher lied. In this period, I took away Leon's computer and told him, no more playing for you until you can prove for me that school is more important than everything else.

Lars told me that Leon have no privacy of talking to the mother and that is somehow true. I have a recording of a 30 min phone call with the mother talking to Leon about his “lies” about being sick. Even if he came home from a Spanish doctor the same day with a diagnose allergic broncit and packed with medicine. And was sent home from school with covid symptoms. Something that can be documented to the same day. This was back in April or May. After this I didn’t want the mother to tell my son that he could not be sick anymore or stopping his feelings. Something Lars apparently agrees with since they didn’t bother to have the evidence to support their “new “case against me. This goes along with every point. And what is really funny know is that the only kids that are sick are the kids at the mum. They are sick at least once a month with a saying from the school that “this is normal”. I have never heard about a kid being sick every month, but this is their statement, and “normal”

Kristin and Lars Told me that they had to write in a report also because of Leon is a 3-grade student and is going in 6-grade. I have prove that Leon gained from second grade to fourth grade in 4 months. They never checked this out even if I have stated this before. I told Lars at the beginning that Leon is a bit behind and fallen even farther behind since the circumstances was not in our favour. From February to may I had to prove to school that the kids where reacting to things while I was struggling with child service, school, the mum and three kids for myself. There was no time or energy to have focus on Leons home school anymore. The mother came in June, July, we had a meeting with child service, she got Gabriel and Nova and they turned red the first day, something I have photos and videos of. Then my life followed to start a law case against the mother since she is refusing that the kids are red with her even if I have evidence of the opposite. The mother manage to take Nova and Gabriel out of the country illegally in the end of July I think. My shitty lawyer went on holiday first of august and that is why I couldn’t have a meeting with him before September. As you know September went to find apartment and a lawyer. October to find new lawyer and build a case. November I got a mail from the Norwegian government that I own them 120 000,- kroner since I didn’t deliver the numbers report on the two companies I had that is now closed down. I am trying to tell them my situation and that I had to think about my kids, but no good feeback. And now we are here today where I have finally started the proses with Leon again, but the school wants it otherwise like the mother. My case against the mother Is finally done so now I can start think about more “normal” things. Kristin the principal tried even to make a point of me not have paid the school fee the last two months, and if she only had asked maybe she would have known that I have been somehow busy and not everything is on my first priority, and maybe it would have been paid the same day. There is only so much a human being can cooperate with in this short time. Its just been to much.

When it comes to the school trying to put a help teacher on Leon, I have proved that this is not necessary. But neither Lars or Kristin have searched out that information from the last school that Leon gained 2-grades in four months on gran Canaria with a normal daily routine on school. I have no reason to trust the Norwegian school system. They have tried to fix Leon for four years in Norway and they failed. I am the only person up to this date that have managed to get Leon to Evolve in school something that can be proven.

And if this report from the school is sent before they get the improvement paper from Canaria on Leon it really shows how little they care about him. They have not cared at all by getting evidence of what is the best for Leon. They have gathered no evidence. My question now is why they are so eager to get Leon home? Why are they jumping of their seat at once the

mother say something and taking her side when I have told them I can prove her words wrong? And she only has words.

Leon has had a conflict with multiple of kids at school for a longer period of time. They have been 2-4 kids against my son alone. Today I got a message from Leons other teacher, his words"

Hello, Leon was in a fight in school today. There was a guy that throw antibac at Leon, and of course Leon got angry. It apparently had been some sort of physical episode yesterday, and more throughout the day today 10.21/2021. We think he have it difficult on school, and we are doing everything we can to protect him and the other students at school. We are verry concerned that he lets his frustration and anger get to kicking and hitting others. He kicked the other guy Jonathan so hard that he got a bruise on his side on the size of a fist. Have nice weekend.

First of all he throwed antibac in his face. Not on him, but on his face. Leon got this in his eyes. I have been in dialog with the school multiple of times before that Jonathan is a guy that brings other kids together to attack my son. My son has not an angel behaviour when it comes to confronting others. But when there are more than 10 episodes of other kids getting behind Jonathan and attack Leon I am actually glad he is defending himself. I don't tell him this because I want the school to fix it but 2 against one is not ok. 3 against 1 is NOT ok, and 4 against 1 IS NOT OK. And when the teacher is typing me this kind of message it is not ok. I Also have recorded his statement of what happened today 10.21-2021 and yesterday. What is really upsetting is that this have been brought up to the teachers with high alert and there is not one single teacher nearby to see what actually happens. So again, the teachers are not doing their jobs. To actually try to manipulate this kind of message into their concern off the mothers "concerns" show how low they are sinking, when my son is the one that gets attacked. This is something that will not be handled gentle from me anymore. I have now understood that after the "case" From Canaria, and now a Case from Costablanca, that you have no interest of listen to what I say, and no interest in whats the best for my kids.

I am started to get so much information of how badly the Norwegian system are protecting my kids that I should start thinking about is this is set up? Are you after me somehow? Why are you not protecting my kid at ALL? Why are the evidence of bad follow up of my kids so obvious? It's like they don't hide from the bad decisions, its just ok to be bad at judgment. And to not go all in on what is really happening is just awful. This school has not either sat themselves in on how Leon was in Norway which is really upsetting since everything is about how 4 years of Leon year was just completely throwed out of the windows from bad teachers, principals, special teacher, mother and so on.

When the meeting started today the principal told me that they brought me in to the meeting off their concerns and that I should listen more than asking and answering. And this is not an option for me off course, so I recorded the meeting, and you find it in the attachments. This Is something I really don't like. Try to manipulate me silent from their bad statements and concerns about Leon. I am not sure how this will work out in the future but the only place my kids have actually had a good time in school with no problems is at Nova's school in the Spanish school system in Mogan Las Palmas. And that is kind of strange that the troubles always follow the Norwegian system. I can say now that Leon is learning Spanish at home now everyday, and we will move out of the Norwegian system as soon as possible, this is a disgrace of treatment off my kids and I will make sure that everything in this case against these two

schools will leak out so other mothers and fathers can start thinking on their own of what is best for their kids in the future, and what they have been taking part of.

I still have not sent this mail and it is the 13.12-2021. This case started because the mother sent a note to the school about Leon wanting home. Yesterday I went on my phone to send my recording of how the mother have been and all the lies she have told. I found out that Leon has deleted my recorder app and that I have lost the recording off the mother. Maybe School and child service should have a talk with Leon about how this happened? I will leave it here for now, but if the mother is getting my son to delete evidence of her bad behaviour it will not go easy. Deleting evidence is prison sentence. But I assume that you will get to the bottom of this since you made this case based on "where" Leon will have it best and will come back to me as soon as possible with an answer. And if you are finding out the truth maybe you should instantly direct the concerns over to Norway and his siblings and bring them back where they belong. It is probably not the best place for them to stay if the mother is manipulating her son to deleting evidence, then you can imagine how she is destroying the smaller ones, like I have told everyone from day one in Canaria.

I texted both of Leon's teachers 12.12/2021 about if I can receive the email to my contact in child service here. I still have not received anything. But I assume that this mail will be sent forward from the principal as soon as possible!
